501(c)(4) / Nonprofit Social Welfare Organization: Activities funded by this entity must be for the promotion of social welfare. This includes anything a 501(c)(3)/Nonprofit Charitable Organization can do, in addition to unlimited lobbying and some partisan political activity. However, partisan political activity cannot be the C4's "primary purpose".

527 / PAC: Activities funded by this entity include anything the C4 can do, in addition to limited lobbying and unlimited partisan political activity.
